The 16th meeting of the 7th Board of Directors of the Company deliberated and passed the *Proposal on the Company's External Guarantee Plan in 2021*. It is considered that the above guarantee plan is mainly required for the subsidiary companies to provide after-sales guarantee for customers in the process of selling machinery and equipment and obtain bank credit and daily operating liquidity loans. The risk of the guarantee plan is controllable, which is conducive to the stable operation of the company's production and operation and marketing, and in line with the interests of all shareholders.

The independent directors of the Company expressed their independent opinions on the guarantee plan. The external guarantee plan of the Company in 2021 is mainly for its wholly-owned subsidiaries to provide after-sales guarantee for customers in the process of selling machinery and equipment and obtain bank credit and daily operating liquidity loans, which is conducive to the stable operation of the company's production and operation and marketing. The guaranteed parties are all wholly-owned subsidiaries of the company, the Company can effectively monitor and manage the production and operation; the guarantee risk involved in the guarantee plan is controllable, and will not damage the interests of shareholders, especially small and medium shareholders.
